


Figure A1: Distribution of the continuous segmentary lineage measure, inputed using information from the *Ethnographic Atlas*.





Notes: A unit of observation is an ethnic group located in Africa and in the Ethnographic Atlas. The independent variable of interest is an interpolated proxy for segmentary lineage organization and the sample includes the full Ethnographic Atlas sample. To construct the proxy, we first estimated the within-sample relationship between the hand-coded segmentary lineage measure with fixed effects for all categories of Ethnographic Atlas variables v 17, v19, v15, and v12. We selected a restricted set of predictors using LASSO and the extended Bayesian information criterion (EBIC). In Panel A, the dependent variables are constructed using all conflicts in the ACLED data; in Panel B they are constructed using civil conflicts; in Panel C, they are constructed using non-civil conflicts; and in Panel D, they are constructed using within group conflicts. All dependent variables are parameterized as $\ln(1+x)$. All specifications include country fixed effects. Columns 2, 5, and 8 also include our set of 'geographic controls' and columns 3, 6, and 9 also include 'goographic controls' and 'historical controls'. Robust standard errors are reported in parentheses. *, **, and *** indicate significance at the 10%, 5%, and 1% levels.
